The Busy Bee in Summer

The swarming season is practically over, though some warms will emerge during July.

The bees are on the home-stretch now, gathering much nectar form the clovers; and about the middle of July is the proper time to harvest the crop and keep it separate from the later fall flow of darker and not so richly flavored honey.

In the matter of giving the bees additional storage room and harvesting the clover honey, one can not of entirely by the calendar, but rather permit the bees to concentrate all their energies upon what sections they have, as it is folly to end the season with a large number of unfinished sections on hand.

Watch the Nectar Supply

If the season has been late, then the wise thing to do is to let the supers remain on even beyond the twentieth of the month, and be governed by the conditions prevailing afield.

Uncapping the Combs for Extracting

In harvesting the honey from the extracting combs, a good sharp honey uncapping knife is a necessity; and two are better than one, as one can remain in a pan of hot hater on the stove while the other is in use, and the knives change with every two or three combs uncapped. Hot water not only leans the knives of honey and wax, but by keeping the knife hot makes it cut more readily.

In any case the knives should be very sharp.

Holding the knife at just the right angle, it is a very easy matter when it is heated to slice off the caps of the combs in the extracting frames, and make them ready for extracting.

The honey and wax that adhere to the knife can be scraped off into a can, and the honey separated from the wax by meting the honey until the wad melts and rises to the surface; when the mass is cooled the wax can be taken off without trouble.

Storage

In harvesting the comb-honey greater care must be exercised, and under no condition should the section combs be stored in a cold damp place.

The cellar is the worst place imaginable for it, and an ice-box is certain to make it sweat and run over the combs and spoil the appearance. The warm attic is an excellent place, but be careful to have it stored so that no robber bees can gain access to it.

By all means use a bee escape board in taking off the supers containing the sections.

From the President....

Annual Election of Officers

Nomination for the election of officers are accepted during the July and August and election of members to office are held at the September meeting with installation to follow at the annual meeting in November as per ARTICLE II, Section 1 of our By-Laws. The official duties of newly-installed officers commence immediately following their installation during the annual meeting in November.

All officers' tenures shall be for a three-year term and there duties are as follows:

President - The President shall be the principal executive officer of the corporation. Subject to the direction and control of the executive Board he/she shall be in charge of the business and affairs of the corporation; he/she shall see that the resolutions and directives of the Executive Board are carried into effect except in those instances in which that responsibility is assigned to some other person by the Executive Board, and, in general, he/she shall discharge all duties incident to the office of President and such other duties as may be prescribed by the Executive Board. He/she shall preside at all meetings of the members and of the Executive Board using the guidelines of Roberts Rules of Order to conduct the meetings.

Secretary - The Secretary shall:

- Handle all correspondence of the association
- Record the minutes of the meetings of the members and of the Executive Board in one or more books provided for that purpose
- Ensure that all notices are fully given in accordance with the provisions of the bylaws or as required by law
- Be custodian of the corporate records and of the seal of the corporation
- Keep a register of the post office address of each member, which shall be furnished to the Secretary by each member, this register to be published and distributed at least once annually and distributed to the membership
- Perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned to him/her by the President or by the Executive Board
- Serve as the registered agent for the association

Treasurer. The Treasurer shall be the principal accounting and financial officer of the corporation.

- Have charge and be responsible for the maintenance of adequate books of account for the corporation
- Have charge and custody of all funds and securities of the corporation, and be responsible therefore, and for the receipt and disbursement thereof
- Perform all the duties incident to the office of Treasurer and such other duties as from time to time may be assigned to him/her by the President or the Executive board.
- File annual tax forms with State and the IRS Ensure members are enrolled in Illinois State Beekeepers Association
- **Director** The Director's primary function is to provide a direct link between the membership and the Executive Board. The duties of the Directors are not limited to any specific area of concern but rather fall in a category of general interest to the welfare of the association of the corporation by whatever means necessary in accordance with the laws of the State of Illinois governing nonprofit organizations

Program Director - The Program Director shall:

- Develop a committee of interested members
- Set up an annual plan of programs with the committee for club meetings which will serve to educate our membership
- Serve as the contact for outside speakers
- Provide membership with information about the program for monthly meetings

PAGE 6 Illinois State Sales Tax

Warning.. This article is not a legal opinion and you should consult with your attorney or tax accountant.

Source - Illinois Revenue -Business Registration web page and Help Desk. You must register with the Illinois Department of Revenue if you conduct business in Illinois, or with Illinois Customers. This includes sole proprietors (individual or husband/wife/civil union), exempt organizations, or government agencies withholding for Illinois Employees.

To register your business you must

- Electronically register through My Tax Illinois (approximately one to two days to process)'
- Complete and mail FORM REG-1, Illinois Business Registration Application, to us at the address on the form (Form REG-1 is available on our web site as a fill-in and savable form. Registration forms are also available by calling us at 1-800-356-6302); or
- Visit one of our offices.

FAQ

Q: I sell honey in Illinois to individuals do I have to collect sales tax?

A: If you sell to end users you have to collect sales tax from them. If they are an Illinois resident then any sales where they are in the business of selling such tangible personal property, they will have to collect sales tax. The only time they do not register is if it is an occasional sale where they are not in the business of selling select tangible personal property (example, garage sale)

Q: What is the sales tax rate?

A: Honey being a food item would be under the food sales tax rate of 1% + local tax rate. Bees, bees wax, pollen and equipment would be under the general merchandise tax rate of 6.25% + local tax rate.

Q: Where do I find the local Sales Tax Rate?

A: The local tax is available under the business tab, select tax rate finder and enter the city or county

Q: Do I have to have an Employer ID Number or can I use my Social Security number to file sales tax?

A: You may register as a sole proprietorship using your SSN.

Q: Do I have to form a company?

A: No

Q: How often do I have to file?

A: First year will either be monthly or quarterly filing frequency, based on tax collected it may decrease to annual

BEE BUZZ

- Q: How often do I have to pay the tax?
 - A: Same as filing frequency.
- Q: What records do I need to retain?

A: Copies of resale certificate or numbers when sold to a vendor. Receipts of sales.

Q: Where do I register to file Sales Taxes in Illinois?

A: You can register online at mytax.illinois.gov under business tab select register a new business form REG-1
